1. WHAT HAPPENED?

In 2019 there has been a number of Incidents on Irish Water sites involving site the use of 6Te Dumpers.

- LTA- IP was struck by a site dumper while the dumper was reversing.
- RTA- At junction, dumper driver did not see vehicle had not moved, proceeded forward and struck car.
- RTA- Operative misjudged turn and the front wheel of the dumper struck a parked car.
- Near Miss operative seated in site dumper (no cab) whilst being loaded.

2. IMMEDIATE ACTIONS

- All dumpers must be operated in accordance with the HSA guidance.
- In all cases site specific safety measures implemented to improve the safe use of 6Te dumper trucks.

3. ACTIONS/RECOMMENDATIONS

- A complete review of current risk assessment to be conducted to verify it includes the use of 6Te dumper truck on public roads and consider the following: distance being travelled, interaction with members of public and operating safely in traffic with other vehicles
- Ensure driver and other site personnel are aware of Dumper blind spots.
- Driver must maintain concentration at all times while operating the dumper e.g. mobile phones must never be used while driving the dumper
- Do not take the vehicle onto the public road unless it is licensed and equipped for use on the road. Obey all driving rules and have consideration for other road users.
- Operators must put the dumper in neutral gear, engage the handbrake and dismount the machine when the skip is being loaded.
- Ensure that loads do not obscure operators field of view
- Ensure that the parking break is applied, the engine is switched off when the dumper is not in use and the key is removed from the ignition
- Ensure that dumpers controls are never operated from anywhere other than the drivers
