
Welcome to the 18th edition of the Infrastructure Delivery Safety Newsletter.

With information and focused feedback sessions on safety, which focused on hazard identification at design stage and the Hazop process, as well as other areas including planning, sustainability, design, programme delivery, commercial and contracts management. The feedback gathered at this event will inform future engagements on how we can work better together as we safely deliver quality, value-for-money, essential water services infrastructure, providing benefits for our customers and communities.



Frontline Supervision update

Following the introduction of the new supervision requirements in PR-029, the Frontline Supervision Working Group has continued to engage with the UÉ Supply Chain and our Delivery Partner Works on the potential impacts to ways of working from augmented supervision requirements.

The Frontline Supervision Working Group is developing a Works Supervisor Training Programme in collaboration with the National Construction Training Centre. Numerous collaborative sessions were held with our Delivery Partners to agree the learning objectives and course content for this bespoke, industry specific training programme. This programme aims to empower site supervisors to be safety leaders. Training materials and course content have been developed and it is planned to launch the training programme by year-end.

Pressure Testing HiPo

During hydrostatic pressure testing of pipework, forks of a teleporter were laid onto the flange to act as a thrust block. This was not specified as per the approved method to test, nor is a teleporter designed to be used in such manner.

Please review your own procedures/RAMS for pressure testing and always ensure that works undertaken at your site are adequately supervised at all times and additional measures put in place for high risks tasks.

Please refer to section 6.5.32 within UÉ minimum Health and Safety requirements document PR029 which will have further detail on pressure testing activities.



Tipper Truck strikes Overhead Line

During a night operation a tipper truck, after leaving a yard, drove in the raised position and struck a number of cables causing damage. All works were ceased, and the area was made safe until ESB and Eir could attend. Although there were no Overhead cables at the temporary site, the PSCS has since implemented hard barriers at exits of yards to ensure tippers are being lowered before leaving.







Strike of 38kv Cable

A contractor was excavating using an insulated hand shovel when the shovel struck an 38kv cable. Nobody was injured but there was localised outage of ESB service. Works were ceased and ESB attended the scene and carried out a repair at the location.

Ensure Code of practice and safe digging practices are always followed during excavation works.

Ensure all hand tools i.e., spades/ crowbars are insulated for electrical services.

The Aim of this COP is to improve the level of safety with which excavation work, and other work involving underground service, is carried out.

Disinfection Programme

Glanua held a Safety Demonstration on their Disinfection Programme to provide practical training and handson experience to team members, emphasising the importance of proper safety measures when working at elevated heights & confined spaces.



Emergency Preparedness

David Walsh Civil Engineering Ltd has carried out a series of emergency Rescue Drills from Cofferdams and installed Defibs on several of their sites with onsite training demonstrations on the use of the defib to heighten awareness. They have also instructed all employees to download the AED Locator app on their Smartphones where possible.



Networks Contractor Stand Down Events

Shareridge hosted a 2-day safety stand down of the theme 'Culture of Care and Openness' emphasising the importance of speaking up when employees feel something may not be right. David Mitchell and Lisa Garrett from UÉ were invited by Shareridge to be speakers at these events.





Farrans held a Soft Start return to work, to highlight Mental Health & Wellbeing, Driving for work and general site safety. Farrans brought all their site teams and Engineers together to highlight and reinforce the Farrans CARES safety message. Their guest speckers were Louise McGeever from the RSA, Aine Kelly from the HSA, Brian Shanks from the Lighthouse Charity and Lisa Garrett from UĚ.

Ward and Burke's safety workforce day focused on some of their Critical Risks and their message was clear - Think Safety, Act Safely. Ward and Burke had 4 guest speakers on the day including Alan Morrissey UÉ. The day was not only about raising awareness on these critical risks but it's also about encouraging action. Ward and Burke management highlighted the importance of getting involved, stay informed and follow company procedures.





GMC's Safety Stand down day focused on construction safety. Guest speaker Matt Hazleton bravely shared his personal experience of a workplace accident. His story served as a powerful reminder of why safety protocols are critical.
