

Pipe Maintenance Responsibility

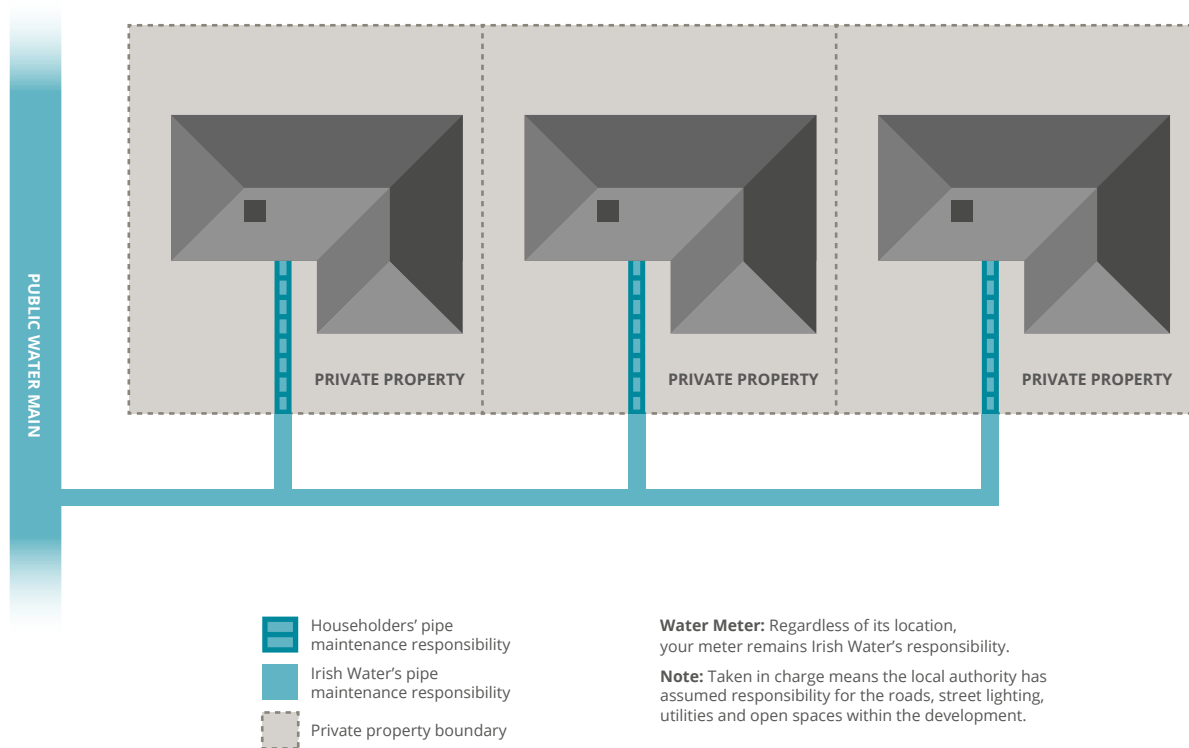

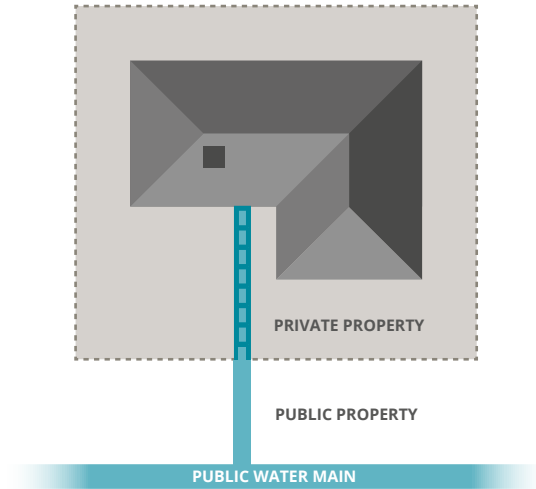

SINGLE DETACHED PROPERTY WATER SUPPLY

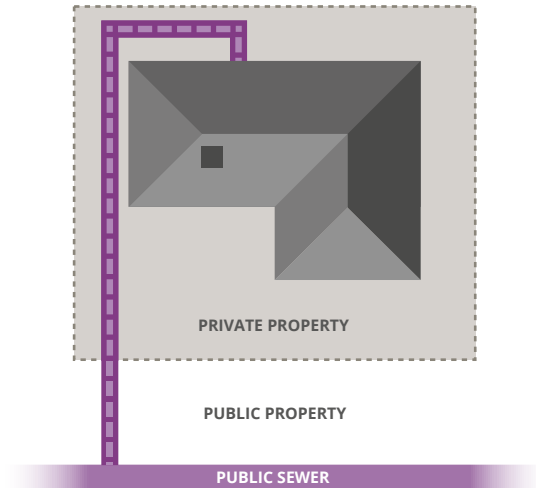





-  Owners' pipe maintenance responsibility

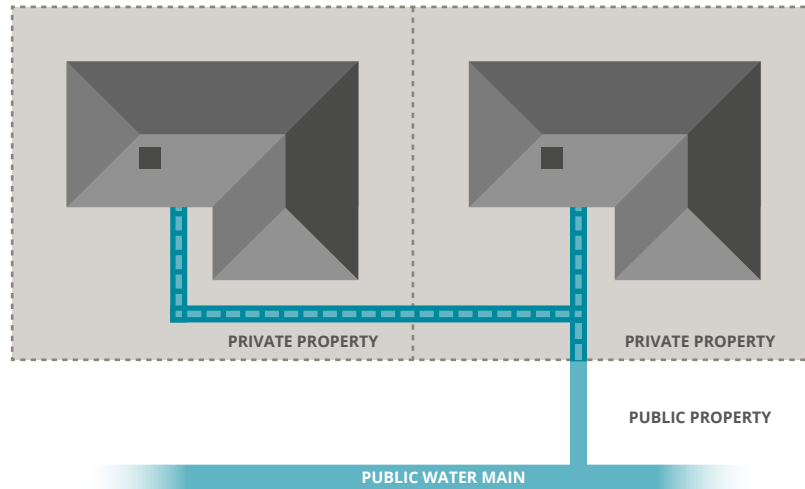
SINGLE DETACHED PROPERTY WASTEWATER

DETACHED PROPERTIES SHARED WATER SUPPLY

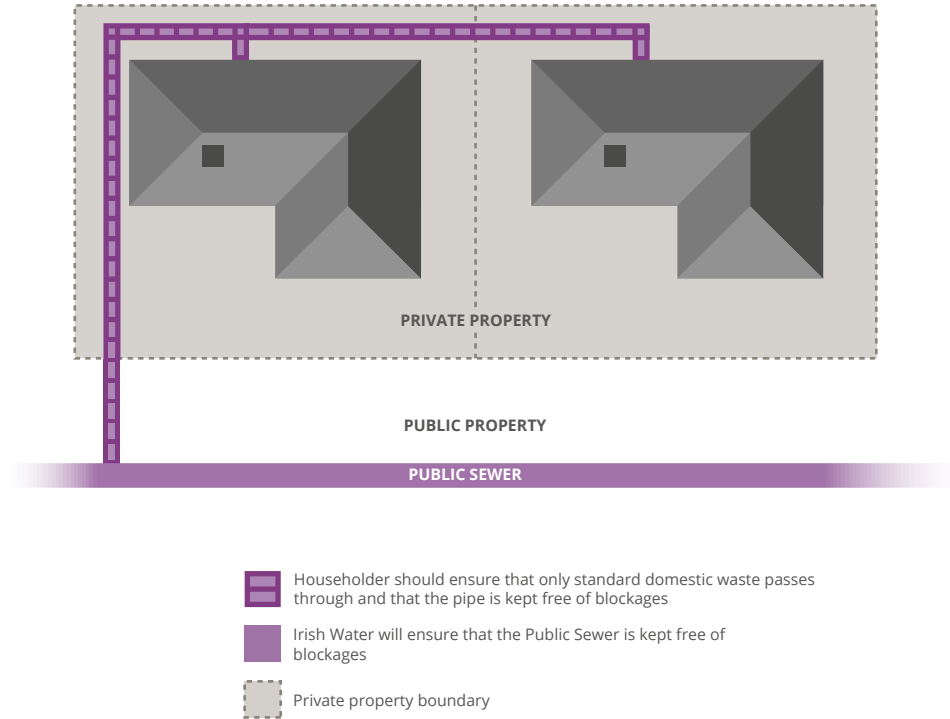


-  Responsibility for pipe maintenance rests with the individual owner or is shared between owners

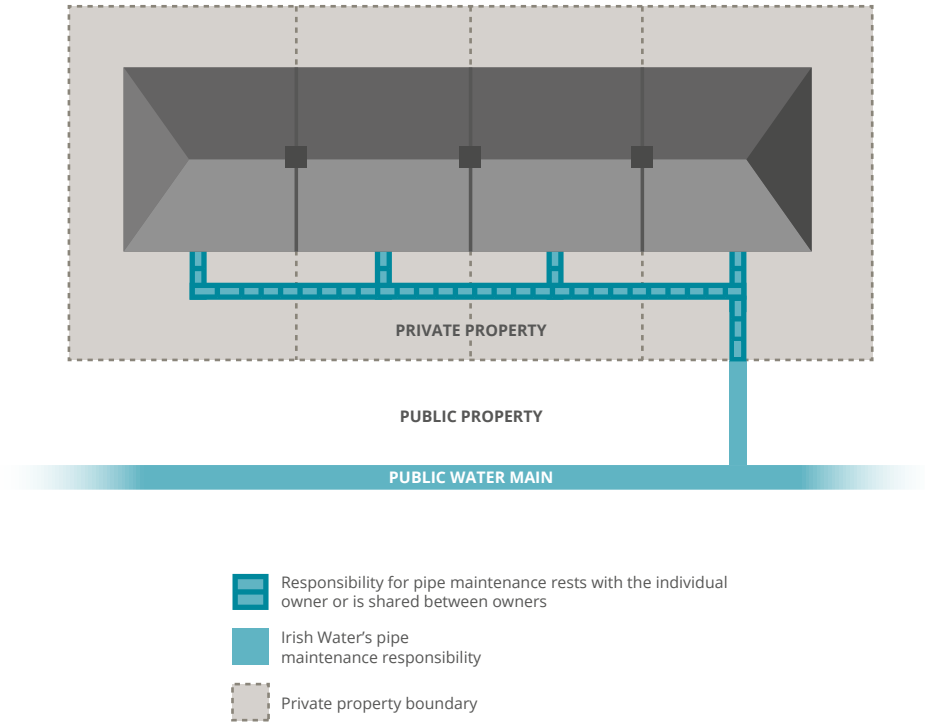

DETACHED PROPERTIES SHARED WASTEWATER



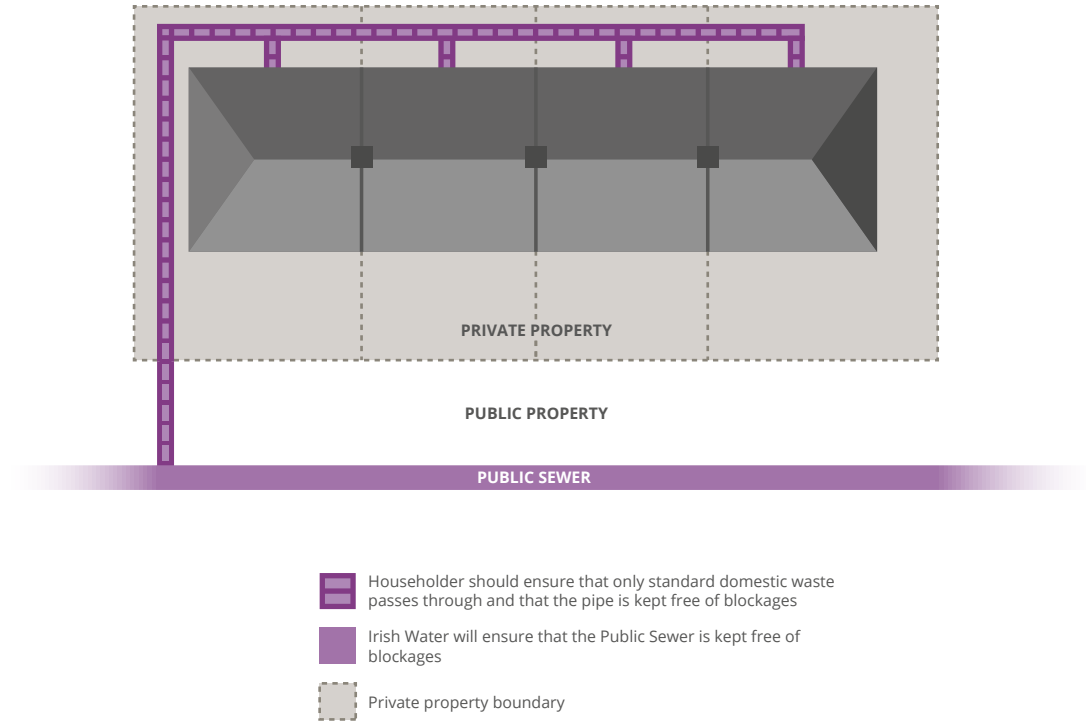

TERRACED PROPERTIES SHARED WATER SUPPLY



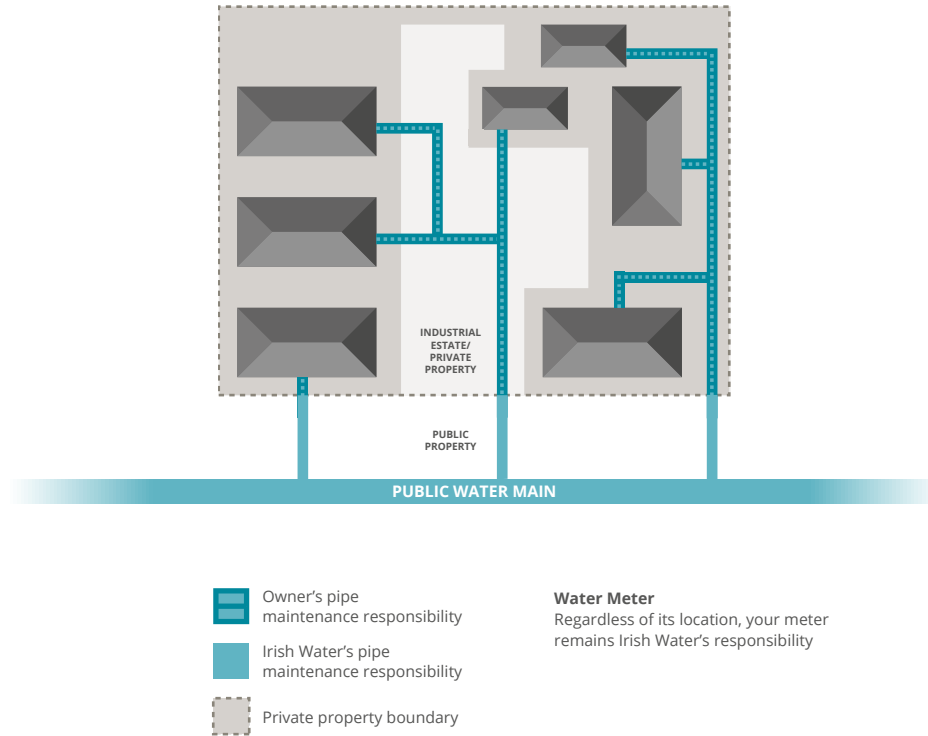

TERRACED PROPERTIES SHARED WASTEWATER CONNECTION



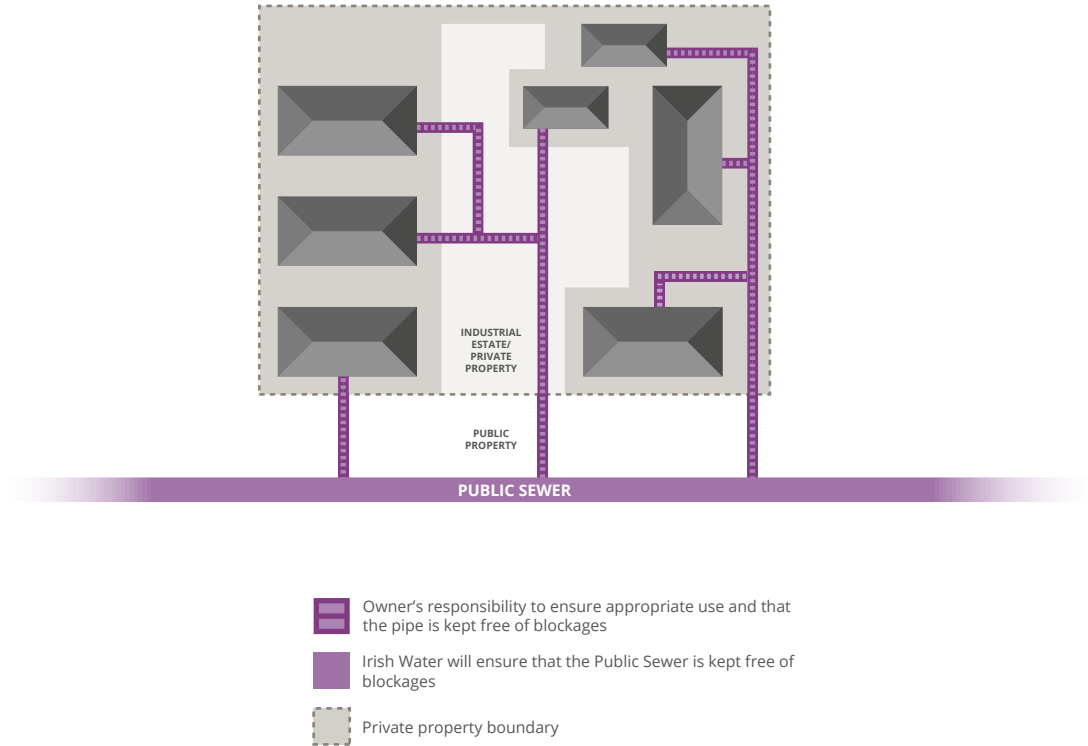
