#### **Significance of Results:**

The untreated discharge was not compliant with the Percentage Reduction from influent concentration set in the wastewater discharge licence.

There is no ambient monitoring data for 2018. The annual programme for costal sampling was completed in January 2018 and the licence for Kilcar was not issued until April 2018. Therefore, no coastal sampling was completed during 2018. Kilcar has been included in the 2019 programme.

The parameters which exceeded the EQS and may be causing an affect are: Not Applicable as no ambient monitoring data for 2018.

The untreated discharge does not have an observable impact on the water quality.

The untreated discharge does not have an observable negative impact on the Water Framework Directive status.

Other Potential cause of deterioration in water quality relevant to this area are: Untreated Agglomeration.
