Appendix 16.2 Case Study Authorised Waste Facilities

Wicklow County Council Waste Facility Permit WFP-WW-16-0038-01

T.P. & S Delahunt Ltd holds a waste facility permit from Wicklow County Council (Number WFP-WW-16-0038-01) for a facility located at Cunniamstown Beg, Rathdrum, Co. Wicklow. The waste facility permit for the facility was granted on 23/1/2017 and will expire on 23/01/2022. The permit is granted for 50,000 tonnes of soil. The facility is therefore a viable destination for some of the surplus excavation waste from the proposed development, providing the intake limit of 50,000 tonnes over the facilities lifetime is not reached prior to the start of construction.

Wicklow County Council Waste Facility Permit WFP-WW-17-0039-01

Bolagh Sand and Gravel t/a ECT Sand and Gravel holds a waste facility permit from Wicklow County Council (Number WFP-WW-17-0039-01) for a facility located at Ballinabarney North, Redcross, Co. Wicklow. The waste facility permit for the facility was granted on 16/6/2017 and will expire on 15/5/2022. The permit is granted for recovery of 25,000 tonnes per annum of construction and demolition wastes including soil and stones. The facility is therefore a viable destination for some of the surplus excavation waste from the proposed development.

Wicklow County Council Waste Facility Permit WFP-WW-10-0017-03

Ray Kavanagh t/a Kavanagh Transport holds a waste facility permit from Wicklow County Council (Number COR-WW-16-0023-01) for a facility located at Stephenson's S&G Pit, Castleruddery Upper, Baltinglass, Co. Wicklow. The waste facility permit for the facility was granted on 16/6/2016 and will expire on 28/4/2020. The permit is granted for up to 50 trucks per day or 100,000 tonnes total intake of excavation or dredge spoil. The facility is therefore a viable destination for some of the surplus excavation waste from the proposed development providing the intake limit of 100,000 tonnes over the facilities lifetime is not reached prior to the start of construction.

Wexford County Council Certificate of Registration COR-WX-17-0131-01

Hennessy Plant Hire holds a Certificate of Registration from Wexford County Council (Number COR-WX-17-0131-01) for a facility located at Knockea, Campile, Co. Wexford. The Certificate of Registration for the facility was granted on 30/11/2017 and will expire on 29/11/2022. The Certificate of Registration is granted for 25,000 tonnes total intake of soil and stones. The facility is therefore a viable destination for some of the surplus excavation waste from the proposed development providing the intake limit of 25,000 tonnes over the facilities lifetime is not reached prior to the start of construction.

Wexford County Council Waste Facility Permit WFP-WX-17-0124-01

Sutton Plant Hire (Wexford) Ltd holds a waste facility permit from Wexford County Council (Number WFP-WX-17-0124-01) for a facility located at Kilcavan (Old Mill), Harristown, Ballymitty, Co. Wexford. The waste facility permit for the facility was granted on 11/6/2017 and will expire on 12/6/2022. The permit is granted for 97,500 tonnes total intake of soil and stones. The facility is therefore a viable destination for some of the surplus excavation waste arising from construction of the proposed development providing the intake limit of 97,500 tonnes over the facilities lifetime is not reached prior to the start of construction.

EPA Waste Licence W0280-01

Roadstone Limited holds a waste licence (Number W0280-01) from the EPA for a facility at Brownswood, Enniscorthy, County Wexford. In relation to soil the licence importation, stockpiling and use of soil and stone for quarry backfill. The maximum annual intake is 400,000 tonnes soil and stones and 1,000 tonnes inert construction wastes. The total amount of soil and stones licensed for backfill at the facility is 1,330,000 tonnes. The licence was granted by the EPA in 2014 however as of 2017 waste activities had not commenced on the site, which is also a working quarry. Should the facility commence waste operations the facility is a viable destination for surplus excavation soil and stones arising from construction of the proposed development.

EPA Waste Licence W0292-01

N&C Enterprises Limited holds a waste licence from the EPA for a facility located at The Pit, Kilmeague, Naas, Co. Kildare. The licence is granted for acceptance, stockpile and use of soil and stone for quarry backfill. The total amount of material which may be used to backfill in the quarry is 1,500,000 tonnes. The facility can accept up to 345,000 tonnes per calendar year of non-hazardous soil and stones and dredging spoil. The waste licence was granted by the EPA on 24/8/2017. Acceptance of waste at the facility was ongoing in 2018. The facility is a viable destination for surplus excavation waste arising from construction of the proposed development.
